**JUBILEE MEMORIAL HOSPITAL** is interested in providing all medical facilities to Staff and Students of the Second Party.


1. The Second Party shall make the following arrangements.
  - a. Space for treatment.
  - b. Table & Chair for the Doctor.
  - c. One Cot with bed.
  - d. Basic Water facility & Wash Basin.
  - e. One stretcher to carry the patient.
2. The Second Party should ensure that Medical Facility will function from 10.00 AM to 12.00PM on all Wednesdays.
3. The First Party will provide the following services:
  - a. Dressing material. (rate should be paid extra as per the use)
  - b. Injections (emergency needs), (rate should be paid extra as per the use)
  - c. Referring the patient to the Hospital or to a higher specialized Medical Centre as the case may be.
4. The first party should provide Doctor and Staff Nurse, and in case of emergency, Ambulance service will be provided according to the availability of Ambulance.
5. The Second Party shall pay an all-encompassing consolidated fixed amount of Rs.1500/- per visit & Ambulance charge extra exclusive of taxes for the full treatment service rendered by the hospital.
6. The First and Second party have agreed on the following terms and conditions.
  - a. The payment for every month certified by the administration personal of the Second Party will be paid before 10<sup>th</sup> of the following month.
  - b. This MOU can be terminated by either side by giving one month notice.
7. This MOU will come into force from the date of signing the MOU and be effective for a period of five years from the date of this agreement.
